

# ONTARIO ENERGY BOARD NOTICE

## **Great Lakes Power Transmission Inc. on behalf of Great Lakes Power Transmission LP has applied to the Ontario Energy Board to increase its electricity transmission revenue requirement.**

**Great Lakes Power Transmission Inc. on behalf of Great Lakes Power Transmission LP has applied to the Ontario Energy Board to increase the amount it recovers from customers in 2015 and 2016. This increase amounts to \$0.01 each month for a typical residential customer. Other customers, including businesses, may be affected as well.**

#### **THE ONTARIO ENERGY BOARD IS HOLDING A PUBLIC HEARING**

The Ontario Energy Board (OEB) will hold a public hearing to consider Great Lakes Power Transmission Inc.'s request. We will question the company on its case for the increase in its revenue requirement. We will also hear arguments from individuals and from groups that represent customers in Ontario. At the end of this hearing, the OEB will decide what, if any, increase will be allowed.

The OEB is an independent and impartial public agency. We make decisions that serve the public interest. Our goal is to promote a financially viable and efficient energy sector that provides you with reliable energy services at a reasonable cost.

#### **BE INFORMED AND HAVE YOUR SAY**

You have the right to information regarding this application and to be involved in the process. You can:

- review Great Lakes Power Transmission Inc.'s application on the OEB's website now.
- file a letter with your comments, which will be considered during the hearing.
  - become an active participant (called an intervenor). Apply by September 2, 2014 or the hearing will go ahead without you and you will not receive any further notice of the proceeding.
- at the end of the process, review the OEB's decision and its reasons on our website.

#### **ORAL VS. WRITTEN HEARINGS**

There are two types of OEB hearings – oral and written. Great Lakes Power Transmission Inc. has applied for a written hearing. The OEB is considering this request. If you think an oral hearing is needed, you can write to the OEB to explain why.

#### **PRIVACY**

*If you write a letter of comment, your name and the content of your letter or the documents you file with the OEB will be put on the public record and the OEB website. However, your personal telephone number, home address and email address will be removed. If you are a business, all your information will remain public. If you apply to become an intervenor, all information will be public.*
